



- ♦ Ongoing Mpox outbreak in 3 Counties

Vaccine-Preventable Diseases

<u>Measles</u>

- One hundred thirty-two (132) suspected cases were reported from 13 Counties (see distribution in table 2)
- Eighteen (18) specimens collected and pending testing
- Eighty-one (81) were vaccinated (see distribution in table 3)




Figure 2: Distribution of Measles Cases by Sex, Liberia Epi Week 18, 2023




Figure 3: Vaccination Status of Suspected Measles Cases by Age Group, Liberia, Epi-Week 18, 2023

Public Health Response

I. Coordination

o Response efforts have been coordinated by CHTs with support from partners

II. Epidemiological Surveillance

- Surveillance activities have been intensified at all levels in affected counties (Grand Kru, Montserrado Grand Gedeh, River Gee, Margibi, and Bong).
- Active case search
- o Line listing of cases

III. Case management

 Patients were managed at health facilities and sent for home-based isolation (Grand Gedeh, Maryland, Grand Kru and Nimba).

IV. Immunization

- Mini campaign in Grand Gedeh County still pending
- o Target age group 7 -59 months
- o Targeted number of children to be vaccinated: 5,927

V. Laboratory

- Specimens were collected from 10 districts in 8 counties for testing (Grand Kru- Barclayville and Trehn, Grand Gedeh-Putu, Konobo, Cavalla, B'hai and Tchien, River Gee- Gbeapo, Potupo, Sarbo, and Webbo, Sinoe- Jedepo, Greenville, Kpanyan, and Tarjuwon, Lofa- Foya, Grand Cape Mount- Commonwealth, Margibi- Kakata, Mamba-Kaba, and Gibi).
- o Five hundred twenty-one cases have been confirmed by the laboratory from December 13, 2021 –April 26, 2023.

VI. Risk Communication and Community Engagement

 A five-day community engagement activity completed in affected and surrounding communities from April 20-24, 2023 in Grand Gedeh County. The activity was supported by Last Mile Health

VII. Challenges

- o Lack of essential medications and medical supplies for case management (Grand Gedeh County)
- o No movement and communication support for the surveillance team for field work (Grand Gedeh County)
- Delay lab result from NPHRL
- Lack of budget support for response (Grand Gedeh)
- Resident DSO (Tchien District, Grand Gedeh County) motorbike is in deplorable condition, and needs repair or to be replaced

Acute Flaccid Paralysis (AFP)

- One (1) case reported from Sinoe County
- Specimen was collected but rejected by NRL
- Cumulatively, twenty-three (23) cases were reported
 - o Ten (10) tested negative
 - o Twelve (12) pending

Neonatal Tetanus

- Zero neonatal tetanus case was reported
- Cumulatively, twenty-five (25) cases including 3 deaths reported

Influenza-Like Illnesses

Coronavirus Disease (COVID-19)

Outbreak

- No new confirmed cases reported
- Cumulatively, eight thousand, twenty-two (8,022) confirmed cases, including 294 deaths
 - 601 healthcare workers
- A total of 17,827 contacts have been generated
 - 1,772 healthcare workers

Public Health Actions

- IMS coordination meeting ongoing
- Surveillance activities including active case search and case investigation ongoing in the affected counties using WHO interim guidelines
- Case management ongoing for confirmed cases
- Compulsory testing among outgoing travelers as required by the country of destination ongoing

Influenza

- Zero suspected case was reported
- Cumulatively, 39 suspected cases reported

Viral Hemorrhagic Diseases

Lassa fever

- Four (4) suspected cases were reported: Bong (2) and Grand Bassa (2) Counties
- Specimens were collected and tested negative
- Cumulatively, one hundred seven (107) suspected cases reported
 - Proportion of suspected cases with a sample collected (95/107) 89%
 - o Proportion of suspected cases with sample tested (95/95) 100%

Current Outbreak

Lassa fever disease

- No new confirmed case was reported
- Thirty-nine (39) contacts under 21 days' follow-up
- Cumulatively, seventy-three (73) laboratory-confirmed cases including 19 deaths reported (CFR=26%)

Public Health Measures

o NPHIL continues to provide technical support to the affected counties

I. Surveillance:

- o Heightened case detection and reporting in affected communities and districts
- Situational reports are produced and shared regularly at the National Level
- o Daily follow-up/monitoring of contacts

II. RCCE

- Health Education in affected and surrounding communities
- o Health workers and visitors are encouraged to enhance IPC practices by regular washing of hands

III. Case Management

o Cases isolated and ribavirin treatment administered

IV. IPC

 Affected communities were empowered with the WASH package to enable them to undertake short-term interventions that will improve the sanitation situation in each community thereby helping in Lassa fever prevention and control

Yellow fever

- Three (3) cases were reported: Sinoe (1), Rivercess (1), and Lofa (1) Counties
- One specimen was collected and pending testing
- Cumulatively forty-four (44) suspected cases reported
 - o Proportion of suspected cases with samples collected (36/44) 82%
 - Three samples were collected but not transported (Epi week 5 from Grand Gedeh, River Gee, and Grand Kru Counties)
 - o Proportion of samples collected and tested (18/36) 50%
 - Negative- 18
 - Pending testing -18

Ebola Virus Disease

Zero suspected case was reported

Diarrheal Diseases

Acute Bloody Diarrhea (Suspected Shigellosis)

- 🖙 Eleven (11) cases were reported: Grand Kru (3), Lofa (3), Nimba (2), Bomi (1), Rivercess (1), and Sinoe (1) Counties
- Five specimens were collected and 1 was not transported from Grand Kru County
- Cumulatively, two hundred thirty (230) cases were reported

- One hundred (100) specimens were collected
 - 51 negative
 - 7 specimens rejected
- o Thirteen (13) specimens were not transported in epi weeks 8, 12, 16 & 18

Severe Acute Watery Diarrhea (Suspected Cholera)

- Fifteen (15) cases were reported: Bong (4), River Gee (3), Montserrado (3), Lofa (2), Grand Gedeh (1), Grand Kru (1), and Sinoe (1) Counties
- Six (6) specimens were collected and 1 not transported from Grand Kru County
- Cumulatively, three hundred fourteen (314) cases reported
 - Ninety-eight (98) specimens collected
 - 42 tested negative
 - 7 rejected
 - o Fifteen (15) specimens were not transported in epi weeks 8, 12, 16, 17 & 18

Other Reportable Diseases

Animal bite (Human Exposure to Rabies)

Seventy-two (72) animal bites were reported

Public Health Actions

Ongoing monitoring and follow-up of cases

Meningitis

- One (1) case was reported from Montserrado County
- Specimen was collected and tested negative
- Cumulatively, seventeen (17) suspected cases reported
 - o Proportion of suspected cases with samples collected (15/17) 88%
 - o Proportion of sample tested (10/15) 67%
 - o 9 negative and 1 positive

Mpox

- Three (3) suspected cases were reported: Sinoe (2) and Nimba (1) counties
- Three specimens were collected: 3 tested negative
- Cumulatively, sixty-five (65) suspected cases reported
 - o Seven (7) confirmed

Outbreak

Public Health Measures

I. Coordination

 National Public Health Institute of Liberia (NPHIL) and Ministry of Health (MOH) and partners are providing technical support to the County Health Teams

II. Epidemiological Surveillance

- Active case search, case investigation, and contact tracing are ongoing in affected and neighboring communities and districts
- Daily monitoring of contacts ongoing by the surveillance team

III. Laboratory

- Ongoing testing of Mpox samples
- Twelve (12) Mpox cases have been confirmed

IV. Risk Communication and Community Engagement

Community engagement and awareness in the affected community and surrounding towns ongoing

V. Key Challenges

- No support from county-based partners for response activities
- Limited IPC materials for response activities
- Limited copies of Mpox standard case definitions

Events of Public Health Importance

Maternal Mortality

- Five (5) deaths were reported: Lofa (2), Montserrado (2), and Gbarpolu (1) Counties
- Reported causes: PPH (2), Sepsis (1), under review (2)
- Reporting Site:
 - o All deaths occurred at the health facility
- Cumulatively, one hundred-fourteen (114) deaths reported
 - Proportion of death reviewed (26/114) 23%
 - o Proportion of community death (15/114)13%

Neonatal Mortality

- 🖙 Ten (10) deaths were reported: Montserrado (7), Grand Bassa (1), Grand Kru (1), and Maryland (1) Counties
- Reported causes: Birth Asphyxia (7), Neonatal sepsis (2) Prematurity (1)
- Reporting sites:
 - All deaths occurred at the health facility
- Cumulatively, two hundred sixty (260) deaths reported

Adverse Events Following Immunization (AEFI)/Adverse Drug Reaction (ADR)

- Nine (9) cases were reported: Grand Kru (4), Grand Bassa (2), Gbarpolu (1), Lofa (1), Sinoe (1) Counties
- All reported cases were non-serious
- Related vaccine:
 - o COVID-19/J&J (3/9) 33%
 - Measles (2/9) 22%
 - o Others (4/9) 44%
- Cumulatively, two hundred fifty-eight (258) events were reported and COVID-19 accounted for (126/258) 49%

Border Surveillance Update

A total of 5,615 travelers were recorded for the week with incoming travelers accounting for 48% (2,692/5,615)
